

## SONY HDMI Authorized Testing Center Application Procedure

<NOTE> HDMI Compliance Test is applicable for [HDMI adopter](#). If you are not a HDMI adopter, please make a contract of the HDMI adopter.

HDCP Compliance Test is applicable for [DCP adopter](#).

Premium HDMI Cable Compliance Test is applicable for [Premium HDMI Cable adopter](#).

### 1. Test Submission Procedures

- 1) Please fill out the Ordering Form from ATC Web Site.
  - Sony ATC will send back to you by Email.
  - Selected ATC lab will also contact you regarding the Test Schedule and Test Target.
- 2) Download the documents.
  - ① If you would ask Testing to this ATC at the first time, please sign the “HDMI ATC Testing Service Agreement” to contract with Sony ATC.
  - ② Please send signed and filled documents to selected ATC and Sony ATC by email.
- 3) Remit testing charge to ATC.
- 4) Ship the test target device (manual, any necessary items) to selected ATC
  - Perform the compliance testing.
  - Send test result and certification to the applicant.
  - Send back the devices to the applicant.

### 2. Submission of the documents

- 1) HDMI ATC Testing Service Agreement
  - \*Only at the first contact to this ATC
- 2) Test Work Order
- 3) Capabilities Declaration Form (CDF)
  - \*We cannot allow Family Model modification once the certificate has been issued.
- 4) HDCP Test Application and Product Capability Form (PCP)
  - \*If HDCP test is required.

### 3. Payment

ATC issues the invoice after the agreement was made. Please remit the test fee by due date set forth in the invoice. If the payment is delayed, the testing might

not be able to be executed.

For the applicant in Taiwan or in China, our Taiwan Lab or Shenzhen Lab will issue the invoice with NT\$ or RMB respectively and the domestic remittance is possible.

**4. Test Charge**

Please refer to the test price list on the Sony HDMI ATC website or the ATC application form. The test price might be changed without notice. Therefore please obtain the latest price information and take the procedure.

**5. Change or Cancellation**

You can change or cancel the test schedule 10 business days before the test starting day. Please note that cancel charge will be generated after such moratorium. Also please understand that the test schedule change request may not be accepted due to other reservation requests.

**6. Shipping**

Please send your test sample to ATC at least 3 business days before the test starting day. The testing requires the followings.

- 1) Test sample :  
Please send the source device with the HDCP function released. Also, if HDCP test is required, please send the source device with the HDCP function as well.
- 2) Related necessary materials :  
DVD or BD etc supported video and audio format for Protocol Test, Signal Generators and Accessories etc.
- 3) Instruction manual :  
Please enclose to operate your test sample. The draft one is acceptable.

All shipment cost (both inbound and outbound) will be charged to consignee.

<Test is failed>

The test result is reported to you by ATC.

The test sample and the accessories are returned at consignee's expense.

Once you corrected the failure, the re-test is possible. The possible and earliest test slot will be informed after submitting your re-test application.

When the re-testing date is determined, please submit the application form, remit the test fee and send the test sample again.
